Every time an angler buys a fishing licence, they make an investment in the future of the sport they love."



We're proud to say that 100% of fishing licence income is reinvested back into angling.

Between 1 April 2022 and 31 March 2023 we sold 903,216 licences, which generated nearly £21,000,000 of fishing licence income. This was reinvested to improve fisheries for people, the environment and angling.

In 2022-23 we collaborated with over 1,000 partners. By pooling funds and resources with like-minded groups and organisations, we were often able to achieve more, and make an even bigger impact.

Some of the organisations that we worked with between 2022 and 2023 included The Angling Trust, Wild Trout Trust, Institute of Fisheries Management, the Riverfly Partnership as well as local river trusts, angling clubs and charities and many more. Thanks to these partnerships, we were able to give anglers:

- Improved fish stocks and habitats
- New facilities and greater accessibility at fisheries
- Promotional campaigns that enabled more people to try the sport
- Joined up enforcement and intelligence sharing

As well as delivering advice to anglers and encouraging more people to access the sport, the Angling Trust also supports enforcement and undertakes predator control, invasive nonnative species and biosecurity work.

Wild Trout Trust (WTT)

With £120,000 funding from us, they:

- Delivered 108 advisory visits and workshops
- Completed 9 river improvement projects
- Enhanced 168km of rivers across England





Riverfly Partnership

With £49,650 funding, their trained volunteers undertook:

♦ 4,253 surveys

Site monitoring at 850 sites across 355 rivers and 103 catchments

Passed on 224 trigger alerts, indicating pollution impact

Over £1.5m of your licence fee was invested into projects that helped improve the overall experience for anglers






Providing a habitat where fish can more easily spawn, feed and avoid predators or extreme weather means anglers have a better chance of catching them! Everyone benefits when we invest in enhancing fisheries."

In 2022-2023 we directly funded over 153 projects that enhanced over 72km of river and 52ha of stillwater fisheries.




Rivers and stillwaters across England benefited from our Fisheries Improvement Programme in 2022-23. The projects helped improve the fishing experience for anglers and protected a wide range of species including coarse fish, trout and eels.

Helping fish access vital river habitat for spawning, feeding and taking refuge by building new fish passes. Providing anglers with improved accessibility through the creation of new angling platforms, enabling more people than ever to enjoy the sport. Protecting of fish stocks.

Enhancing fisheries habitat.



Since 2015, over 1000 projects have been successfully completed, with a total of £7 million invested from fishing licence sales alone."





Chinnor Works Angling Society:

Improved fishery's resilience to cormorant predation and provided additional habitat.

- Three floating reed islands constructed, providing refuges and additional habitat.
- Three underwater reefs built to protect resident fish stocks from cormorant predation.

River Dore, Herefordshire:


Weir removal to improve river connectivity and fish passage for all fish species.


Reinstatement of more natural river features replacing previously impounded section of river. **iCARP:** Creating sustainable stillwater habitats for coarse fish, and enhancing the lakes as an angling and wellbeing centre.

- Installation of an office, on-site therapy rooms and predator prevention fencing.
- Ground, tree and brush management.
- Creation of on-site facilities, swims and biosecurity options.

Ripple free fishery: Improving access on a prime free coarse fishery on the River Severn in Worcestershire.

Construction and maintenance of 20 fishing platforms. With your help, we stocked over 455,000 fish into our rivers and stillwaters





Thanks to anglers like you, we were able to restock our rivers and stillwaters with 455,439 fish"

We use fishing licence income to rear fish to release into our rivers and stillwaters. This provides anglers with a more enjoyable experience, but also means that we are ready to replenish stocks if there is an environmental incident. It also helps to kickstart recovery from longer term issues like pollution.




Fishing licence income helps fund the National Fisheries Laboratory in Cambridgeshire."

Unlicensed anglers face a fine of up to £2500





It's much easier to make decisions about managing fisheries and planning improvements when you understand the status of fish populations in our rivers and stillwaters."

Our management decisions and reports on the state of the water environment are made on the basis of the information we gain from our regular and extensive fish stock surveys and water quality monitoring – this takes place on the rivers and stillwaters of greatest fishing interest or most at risk.

Paperless licence

Our goal is to be net carbon zero by 2030. One of the ways you can help us achieve this is by buying a digital licence.
